**ARTIST'S BIOGRAPHY**

A biography, for public reference, may be included with the entry form. Please restrict to one A4 sheet. Biographies are displayed in a suitable folder for visitors' easy reference. We receive many requests for artist's information from prospective buyers and biographies are most helpful to us.

**Arts For Community raise funds for its Charity work within the community. AFC act as your agent during the Exhibition and any and all sales during the Art of the Body Exhibition.**

**ENTRY REQUIREMENTS TERMS AND CONDITIONS**

The Artist's signature on the entry form declares that the Artist has read the following terms and conditions and accepts fully, any, and all decisions made or implemented by **ARTS FOR THE COMMUNITY** (hereby known as **AFC**).

**All decisions by the AFC committee are final and no correspondence will be entered into.** Artworks must be the original work of the Artist and completed within the last **12 months and must be available for sale.**

**ENTRY**

A non-refundable entry fee of **\$15.00** per work (maximum **2** per artist)

Note—2 **MINIATURES** are classified as 1 entry, thus 4 miniatures are acceptable

Applications forms not accompanied by full payment of all entry fees are not eligible for assessment or hanging.

Entries must be received by 4pm Friday the 14th March 2008.

**ARTWORKS**

**Paintings**

Paintings must be suitably framed and strung ready to exhibit (**Area of Artwork including framing not to exceed 2. 5 sq metres**). Cord or wire secured on 'D' rings required for hanging. Works with fishing line and/or any other type of securing devices are not permitted.

**Three Dimensional Art**

Three dimensional art i.e. sculptures etc, must be safe, stable, free standing and not exceed **25kg** (no dimension longer than 1.5m)

All artworks must be clearly marked or labelled on the back or base of all entries with the following information clear and legible, Artist's name, address phone number, dimensions, title, medium, and price of the work.

**AFC WILL NOT BE RESPONSIBLE FOR ANY LOSS OR DAMAGE WHATSOEVER OR HOWSOEVER CAUSED, TO ANY WORK WHILE IN THE CUSTODY OF THE AFC.** You must maintain your own insurance cover.

**RECEIVING OF ARTWORK**

You are responsible, both financially and logistically, for the delivery and return of your Artwork.

Delivery of artworks is required between 9am—12 noon **SATURDAY 15th March 2008** at the site **UNDER NO CIRCUMSTANCES** will works be accepted after this date.

Items will be receipted upon delivery and your receipt **WILL** be required for collection of artwork  
Collection on **TUESDAY 25th March 9am—5pm**

**ENTRY DETAILS**

All personal details will be kept confidential unless you elect to allow AFC to add your details to their database for advisement of future exhibitions and events.

**INSTALLATION**

The art co-ordinators will install the exhibition. The co-ordinators may fix or alter hanging hooks or other hanging devices as required. The arts co-ordinators retain the right to manage all aspects of installation. Any exhibitors required to be on site during an installation must adhere to all **Workplace Health and Safety** procedures and to any **AFC** directions.

All decisions regarding suitability will be the ultimate decision of the AFC and its co-ordinators.

Whereas the amount of entries exceed the available hanging/display space, all entries will be fairly judged and the co-ordinators will hang/display artworks at their unbiased discretion.

**PUBLICITY AND PROMOTION**

The artist gives consent by entry to allow AFC to reproduce artwork for publicity and promotional purposes, including, in electronic and print media at AFC's discretion.

A catalogue of works to be exhibited will be produced for the exhibition by the **AFC and its co-ordinators**
